The Philippine Mission to the United Nations and Other International Organizations in Geneva, Switzerland pursuant to Republic Act No. 11639 – FY 2022 General Appropriations Act and the Department of Budget and Management's Authority to Purchase Motor Vehicles (APMV) No. D3-22-00010 dated 02 June 2022 and the Department of Foreign Affairs-Office of Fiscal Management Services fax authority no. GE-272-OFMS-2022 dated 09 June 2022 intends to apply the sum of Five Million One Hundred Seven Thousand Philippine Pesos (PhP5,107,000.00) or its equivalent of approximately US Dollars Ninety Nine Thousand One Hundred Seven and 92/100 (US\$99,107.32) being the Approved Budget for the Contract (ABC) to payments under the contract for the "Procurement of an Official Car for the Use of the Philippine Mission to the United Nations and Other International Organizations in Geneva, Switzerland". Bids received in excess of the ABC shall be automatically rejected at bid opening.

8. The BAC shall select the successful offer on the basis of such best and final offer which should meet the project’s minimum technical requirements and should not exceed the approved budget.
9. The BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without incurring any liability to the affected participants.
