1. Public Bidding for the sale of motor vehicle with the following details:

2. The Bidding shall be subject to the following terms and conditions:

a. The Sale shall be on "AS IS, WHERE IS" basis

b. Who may participate in the Public Bidding

Any person, partnership or corporation complying with the prescribed rules and regulations may participate in the sale by public bidding.

3. Pre-Bid Conference

A pre-bid conference will be held on 22 May 2024 at 1600H at the Philippine Mission. The objective is to provide bidders with the opportunity to clarify from the Disposal Committee on any areas or issues regarding the bidding.

4. Submission and Receipt of Bids

Sealed bids which shall be addressed to the Disposal Committee will be received at the Philippine Mission not later than 24 May 2024 at 1600H.

BIDS SUBMITTED AFTER THE DEADLINE SHALL NOT BE ACCEPTED by the Committee

Bidders shall submit their bids through their authorized representative or by mail in the Prescribed Bid Form on or before the specified deadline.

5. Bid Award

Notice of Award shall be given to the highest complying and responsive bidder.

6. Payment

a. The winning bidder shall pay the bid item equivalent to the offered price.

b. An Official Receipt shall be issued by the Philippine Mission covering the payment made by the winning bidder.

7. The winning bidder shall withdraw the items awarded within five (5) working days.

8. All expenses incidental to the withdrawal of the bid item shall be borne by or are for the sole account of the winning bidder.

9. The Philippine Mission reserves the right to reject any or all bids, to waive any informality found therein, and to accept such bid or bids as may be considered most advantageous to the Mission.
